2 conservator of the person and co-conservator of the estate of Britney Jean Spears, and Andrew  
3 M. Wallet ("Mr. Wallet"), co-conservator of the estate of Britney Jean Spears, came on regularly  
4 before this Court for hearing on April 21, 2009. Joel E. Boxer of Bird Marella Boxer Wolpert  
5 Nessim Dooks & Lincenberg appeared on behalf of Mr. Spears and Mr. Wallet. Geraldine A.  
6 Wyle of Hoffman, Sabban & Watenmaker and Jeffrey D. Wexler of Luce, Forward, Hamilton &  
7 Scripps LLP appeared on behalf of Mr. Spears. Mr. Wallet appeared *in pro per*. Bryan J.  
8 Freedman and Bradley H. Kreshek of Freedman & Taitelman, LLP appeared on behalf of  
9 respondent Osama ("Sam") Lutfi ("Mr. Lutfi"). Roger Jon Diamond appeared on behalf of
