
1 I, Mel Steiner, declare:

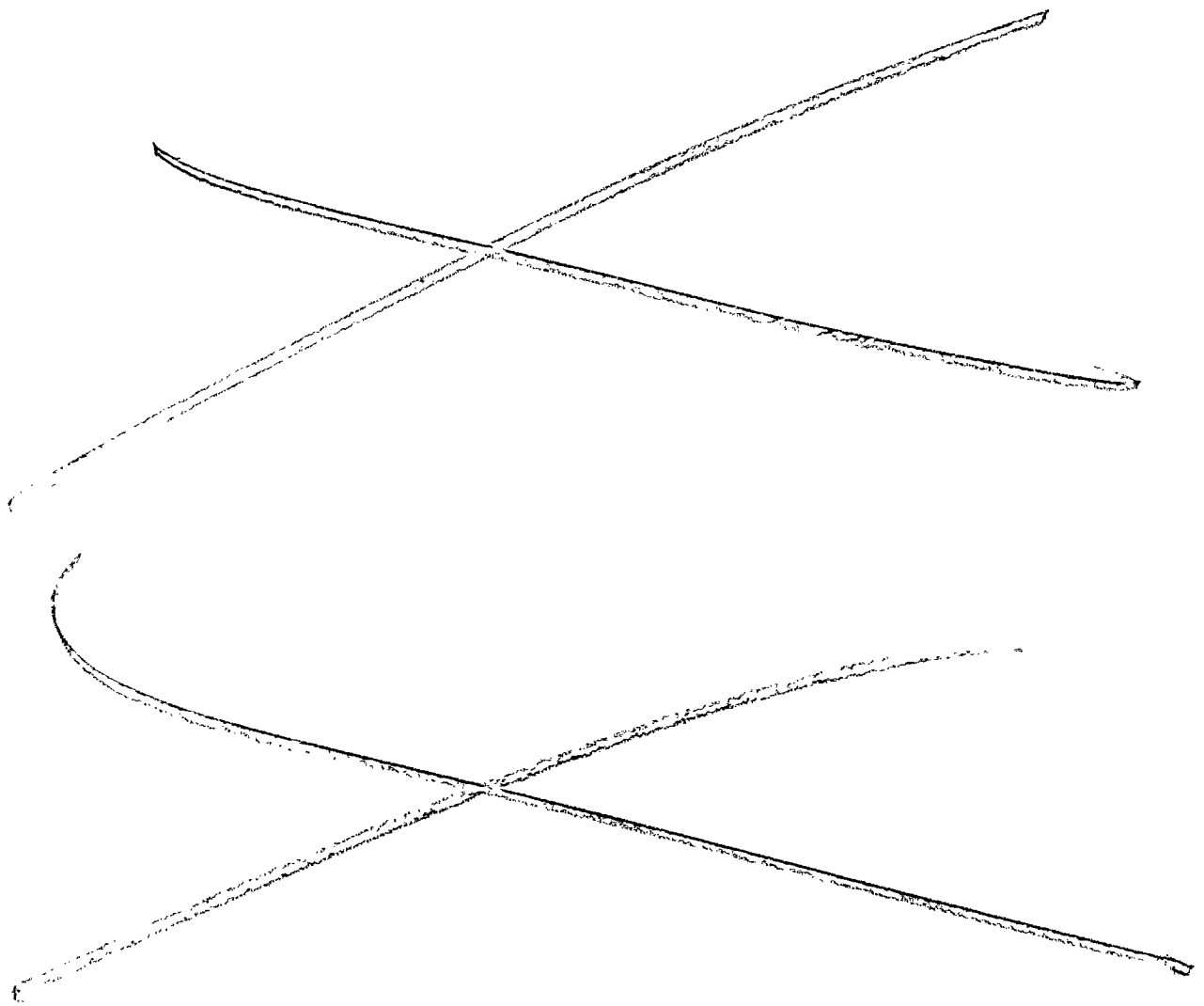
