1 The Ex Parte Application for Order Approving Agreement with Brand Sense Partners,
2 LLC ("Brand Sense") filed by James P. Spears ("Mr. Spears") and Andrew Wallet ("Mr. Wallet")
3 as Co-Conservators of the Estate of Britney Jean Spears came on for hearing at 8:30 a.m. on
4 February 9, 2012, in Department 9 of the Los Angeles Superior Court, located at 111 North Hill
5 Street, Los Angeles, California 90012, the Honorable Reva G. Goetz, presiding. Geraldine A.
6 Wyle of Hoffman, Sabban & Watenmaker APC appeared on behalf of Mr. Spears. Samuel D.
7 Ingham III appeared as court-appointed counsel on behalf of Conservatee Britney Jean Spears.
8 Andrew M. Wallet of Hinojosa & Wallet appeared as Co-Conservator of the Estate of Britney J.
9 Spears.

10 After considering the pleadings, and good cause appearing therefore, the Court finds,
11 determines, orders, decrees and adjudicates as follows:

- 12 1. Notice was given as required by law;
- 13 2. Approval of this Agreement is in the best interests of Ms. Spears;
- 14 3. All of the allegations of the Ex Parte Petition for order Approving Agreement are
15 true and correct;
- 16 4. The Settlement Agreement and Mutual Release is approved, including the material
17 terms as set forth below:


- 18 • For calendar years [REDACTED], Brand Sense shall receive [REDACTED]
19 [REDACTED] commission on any amounts paid to Britney Brands on the
20 sales of fragrance and related ancillary products: hair, face, skin, body
21 care, bath and cosmetics (collectively, "Licensed Products") by
22 Elizabeth Arden per the original Elizabeth Arden Agreement between
23 Elizabeth Arden and Britney Brands, as amended, and the new
24 Elizabeth Arden Agreement between Elizabeth Arden and Britney
25 Brands.
- 26 • For calendar years [REDACTED], Brand
27 Sense shall receive a [REDACTED] commission on any amounts
28 paid to Britney Brands on the sales of Licensed Products per the original

Elizabeth Arden Agreement, and the new Elizabeth Arden agreement.

- From [REDACTED], onward, Brand Sense shall receive a [REDACTED] commission on any amounts paid to Britney Brands on the sales of Licensed Products.
- Defendants shall pay to Brand Sense [REDACTED] in four equal installments of [REDACTED], on February 15, 2012, May 15, 2012, August 15, 2012, and November 15, 2012;
- Within three (3) business days of approval of the Agreement by this Court, Brand Sense shall file a request to dismiss its first amended complaint with prejudice and Britney Brands shall file a request to dismiss its cross-complaint with prejudice.

Good cause appearing, IT IS SO ORDERED.
