1 The Fourth Account Current; Report of James P. Spears and Andrew M. Wallet, Co-
2 Conservators of the Estate; Petition for its Settlement and Approval Thereof (filed on February 1,
3 2013, as supplemented on June 14, 2013 (the "Petition") came on regularly before this Court for
4 hearing on June 28, 2013. The Honorable Judge Reva G. Goetz presided.

5 Jeryll S. Cohen of Hoffman, Sabban & Watenmaker, APC appeared on behalf of James P.
6 Spears, who also appeared. Andrew M. Wallet appeared *in pro per*. Samuel D. Ingham, III,
7 appeared as Court-appointed counsel for Britney Jean Spears ("Conservatee").

8 Having considered the record, the pleadings, the declarations and oral argument, from
9 proof made to the satisfaction of the Court, the Court finds as follows:

- 10 1. Notice of hearing has been given as required by law.
- 11 2. Petitioners have been serving as Co-Conservators of the Estate since October 28,
12 2008.
- 13 3. On February 2, 2008, the Court appointed Samuel D. Ingham, III as the PVP
14 attorney for the Conservatee. The Court has not discharged Mr. Ingham as the PVP attorney.
- 15 4. The value of the assets the Co-Conservators have in their possession belonging to
16 the Conservatee that are subject to the conservatorship (which does not include the substantial
17 assets the Conservatee has that are not subject to the conservatorship), as of the close of the
18 accounting period, December 31, 2011, as reflected in the Account (which is not reflective of
19 current fair market value) is \$25,335,509.66, consisting of cash in the amount of \$5,780,701.72
20 and non-cash assets in the amount of \$19,554,807.94 as reflected on Exhibit 1 of the First
21 Supplement.
- 22 5. The bond is set and filed in the amount of \$25,000,000.00 for Mr. Wallet and
23 \$1,500,000.00 for Mr. Spears, which is sufficient.
- 24 6. All the acts, transactions, sales and investments of Petitioners, James P. Spears and
25 Andrew M. Wallet, during the period covered by the Account are truly shown and should be
26 approved, and all of the allegations in the Petition are true.
- 27 7. There are no objections to the relief requested in the Petition. The Account

1 covering the period of January 1, 2011, through and including December 31, 2011, is full, true and
2 correct and should be settled, allowed and approved as filed and supplemented.

3 8. The residence address of Conservatee is reflected in the Post-Move Notice of
4 Conservatee filed conditionally under seal on February 10, 2012, and served on all persons
5 entitled to notice.

6 9. The Conservatee is not receiving and will not receive money from or through the
7 Veterans Administration. The Conservatee does not receive revenue or profit from money
8 obtained from the Veterans Administration. The Estate does not include property acquired wholly
9 or in part, from money from the Veterans Administration.

10 10. The Conservatee has not been confined in a state hospital in California during the
11 pendency of these proceedings.

12 **WHEREFORE, IT IS ORDERED, ADJUDGED AND DECREED** as follows:

13 1. The Fourth Account Current and Report of James P. Spears and Andrew M. Wallet,
14 Co-Conservators of the Estate; Petition for its Settlement and Approval Thereof (the "Petition"),
15 covering the period of January 1, 2011, through and including December 31, 2011, as
16 supplemented, is settled, allowed, and approved as filed;

17 2. All the acts, transactions, sales and investments of the Co-Conservators as reported
18 in the Petition and account as supplemented are ratified, approved and confirmed.


