**ORDER CLARIFYING ORDER
APPOINTING PROBATE
CONSERVATOR OF THE PERSON**

1 The Status Conference came on regularly for hearing in Department 9 of the above-
2 referenced Court on March 11, 2014 at 8:30 a.m. Geraldine A. Wyle and Jeryll S. Cohen
3 of Hoffman, Sabban & Watenmaker, APC, appeared on behalf of Mr. Spears. Samuel D.
4 Ingham, III, appeared as court appointed counsel for Britney Jean Spears. Andrew Wallet,
5 Co-Conservator of the Estate, appeared in *pro per*. The Honorable Reva G. Goetz
6 presided.

7 Having reviewed the record and heard counsel, and finding that notice has been
8 given as required by law, and good cause appearing therefor:

9
10 **IT IS HEREBY ORDERED** that:

11 The Order Appointing Probate Conservator of the Person in the above-referenced
12 matter, dated January 5, 2009 (the "Order"), including without limitation Paragraph 29,
13 subparagraph 1.d., remains unchanged. The purpose of this Order is to clarify the meaning
14 of Paragraph 29, subparagraph 1.d. Subparagraph 1.d states:

15 The Conservator shall have the power to communicate with
16 treating and other expert medical personnel regarding the Conservatee,
17 and to have access to any and all records (except psychiatric records)
18 regarding the Conservatee's medical treatment, diagnosis and testing.

19 The Conservator shall have access, subject to the reasonable discretion
20 of the Conservatee's primary treating psychiatrist located in Los
21 Angeles County, to any and all records regarding the Conservatee's
22 psychiatric treatment, diagnosis and testing.

23 This Court clarifies the meaning of the foregoing language to mean that Mr. Spears,
24 as well as any consultant that he retains as his agent, shall have access, to the
25 Conservatee's medical records and the power to communicate with the treating medical
26 personnel.


27 For purposes of clarification, Paragraph 29, subparagraph 1.d, should be interpreted
28

as follows:

1. The Conservator of the Person is granted the following powers in addition to the powers provided by law...


d. The Conservator, or any consultant retained by the Conservator as his agent, shall have the power to communicate with treating and other expert medical personnel regarding the Conservatee, and to have access to any and all records (except psychiatric records) regarding the Conservatee's medical treatment, diagnosis and testing. The Conservator, or any consultant retained by the Conservator as his agent, shall have access, subject to the reasonable discretion of the Conservatee's primary treating psychiatrist located in Los Angeles County, to any and all records regarding the Conservatee's psychiatric treatment, diagnosis and testing.
